### **IWWA Agency Application Submission Requirements**

The following information must be submitted when filing an application for an Inlands Wetlands and Watercourses Permit.

1. Original plus 11 copies of detailed site plans including the “limits of disturbance”.
2. Original plus 11 copies of the completed application form signed by the owner of record.
3. Applicable Application Fee.
4. Original plus 11 copies of CT DEEP Reporting Form.
5. Start Card (The Start Card must be submitted only after issuance of the Wetlands permit and before any work is started).
6. Finish Card (The Finish Card shall be submitted following completion of all approved work).

Refer to Section 7, Application Requirements and Section 8, Application Procedures, of the 2010 IWWA Regulations for specifics.
