ROADWAY, PARKS & BUILDING MAINTENANCE

Laborer Seasonal maintainers work primarily in Roadway, Sanitation, Recycling, Transfer Station, Parks, and Beaches. Work may include daily maintenance of roads, street cleaning, landscaping, etc. Routine and unskilled or limited work of a semi-skilled nature in both cleaning and servicing motor vehicles and in guarding buildings, grounds, and facilities against trespassing, theft, and fire.

Camp Site Directors Under the direction of the recreation staff, this position is responsible for the day-to-day management of planning daily activities and scheduling for staff and participants. The Summer Camp Director contributes to the well-being of our community by providing a fun, safe, and supportive experience for campers. The Summer Camp Director helps lead summer camp education for children ages 5-10 years old. The Camp Director is the primary staff member in charge of logistics, safety, and camp materials.

- Previous experience working in a municipal recreation department or similar organization
- Certification in First Aid and CPR
- Strong organizational and communication skills
- Ability to work well with children, parents, and staff members

Camp Site Coordinators These individuals as a general operating practice keep daily records of camper attendance as well as staffing assigned to their age group while reporting to the Camp Supervisor and other Recreation Staff. Acts as a delegate for issuing and interpreting general operating policies as well as ensuring safe best practices and all camp counselors adhere to rules and regulations. Under the direction of the Recreation Coordinators, this person supervises all staff at Summer Day Camps. Each Site Coordinator manages Camp Groups ages 5-10. Parents and Guardians can find out the progress of their camper(s) at the time of drop-off and dismissal by discussing the daily schedule with the Site Coordinators. Weekly timesheets are also collected and reviewed by campsite coordinators and distributed to the Camp Supervisor and Recreation Staff.

Qualifications:

- Prior experience in supervising and working with children.
- Ability to plan and lead activities for large groups of children.
- Excellent interpersonal and communication skills.

Hours Per Week: 35 Hourly Rate: \$17.00 Camp Counselors These individuals assist Site Coordinators with planning arts and crafts activities, sports games, events, competitions, reading and writing initiatives, and other daily activities. Camp Counselor duties include handling sign-in and sign-out sheets, filling out accident reports when first aid is needed, and interacting with and engaging campers throughout the day. They are assigned to supervise campers when attending field trips under the direction of the Site Coordinator.

Applicants must be at least 18 years of age to apply.

Water Taxi Captains These individuals are needed to pilot water taxi vessels, schedule personnel shifts, and operations, fulfill USCG requirements count per trip, report to the Harbor Master and Parks Department Head and/or his designee, maintain vessels, respond to emergencies, and provide customer service to residents.

- Considerable knowledge of seamanship, vessel operation, and handling.
- Considerable knowledge of all pertinent regulations of the United States Coast Guard regarding type "T" passenger ferries.
- A familiarity with all pertinent regulations of the United States Coast Guard, Subchapter H, Maritime Security.
- Knowledge of navigation hazards and weather conditions in Long Island Sound.
- Knowledge of maintenance and repair needs of vessels, marine engines, and auxiliary equipment.
- Considerable knowledge of the needs and uses of standard safety equipment for vessels and the ability to provide and direct the use of such equipment in emergencies.
- Ability to operate passenger vessels up to 100 gross tons. Operate marine auxiliary equipment. Operate machines, power tools, and equipment used in several buildings and marine trades and two-way radio systems.
- Ability to perform the physical aspects of the position including heavy lifting, 100 lbs. occasionally, 50 lbs. frequently, 20 lbs. constantly, 7 hours per day. Remaining at the helm of a vessel up to 12 hours a day. Pushing, pulling, carrying, and climbing as well as boarding and offboarding vessels, docks, and floats. Enter and work in tight vessel compartments.
