City Financial Issues.

Twelve and a half years ago, in 2002 The Bridgeport Port Authority last approved a set of by laws. For reasons unknown at the moment the purpose of the Port Authority and its by-laws have not been well understood by the public, nor have they been lived up to in reality by stakeholders in the City.

Basically there are three members of the public appointed by the Mayor and approved by the Council. Unfortunately, there has been one vacancy on the Commission for more than 6 years even though the City web site continued to list three active community members, and two of them indicate 'terms expired'. This happens too many times in the City and vacancies make quorums difficult to assemble.

For about 6 years, the BPA has had an acting Exec Director in the presence of the former Chief Administrative Officer. Previous to CAO Nunn adding this responsibility to his City burden, the Port Authority had retained a CPA to prepare financial statements that were available at each meeting. Outside audits showing operating expenses and revenues as well as assets and liabilities were routine at the time. There appear to have been no such records, reviews or audits on which any Commission member could rely during the past six years. There has been adequate revenue to compensate at least two employees and for an interest payment annually of nearly \$100,000 on a \$900,000 mortgage note signed in 2005 against BPA properties that includes at least 42 acres on the east side of the harbor and the ferry terminal on the west side. But does the quasi public authority require a specific audit at this moment to reboot its process or come up to speed to meet State statutes?

The Port Authority has the responsibility of developing the port region. In terms of revenue production or economic development what revenue is generated or what is planned for the entire acreage? The record is certainly not clear at the moment as to whether appropriate voting on existing agreements has been held by "disinterested parties" for instance. Is there additional debt or obligations other than the \$900,000 obligation that carried a 10.75 interest rate per annum for 10 years? Why was this note not refinanced to a lower rate by the BPA? That is a \$96,750 expense paid to a Westport real estate financing firm since 2005 that has used Willinger, Willinger and Bucci for legal services on occasion.

In November 2015 a series of emails went between City Hall including City Attorney and Titan Capital, the lender, as well as Thomas Sherwood of OPM. Sherwood approved a transfer of \$955,000 from Code 59999 (an accounting entry into which Capital funds are moved temporarily until they are assigned to a specific and detailed project) as there were “not enough funds in line 59500”. This is contemporary with a purchase order-backed check to Construction Management Services identified as “repayment of mortgage note” \$900,000 and \$9,250 as payment note for Port Authority. Why was CMS in this activity?

Did the \$955,000 from OPED capital account originally come from bonds covered by legal instruments outlining responsibilities and limitations on the City? It seems so. Was such transfer legal or sensible? What power did the OPM director believe he was exercising in organizing this last minute financial transaction? What are the current limits on City transfers of any kind without City Council approval? How many times has the executive department sought such approval in the past 2 years? Because the City Attorney Office was part of the communications tree at the time of the debt payment, were any flags raised about the suitability of this transaction or the manner in which it was executed?

This inquiry has raised an article on Only in Bridgeport and again today from Brian Lockhart of the CT Post. Are you confused by the story? Are you disturbed by how easy it seems for the executive branch to leave you out of decision making and info? How will you use your authority to respond?

And while you are at it, will you allow the City to spend \$2 Million of capital from bonding for police cars that will be fully depreciated in five years yet still cost the City interest and principal payments for all 20 years? All of you are voters on the matter. Is that the way to purchase automobiles? Would you recommend it to family and friends? Time will tell.

Retirement of the Bridgeport Harbor Coal
Plant.

Ms. Lewis came forward and said she was the Executive Director of the CT Coalition for Environmental Justice. The Center has offices in Bridgeport, Hartford and New Haven. She said that she was in favor of the Community Agreement.

Ms. Lewis went on to say that the Citizen’s Action Committee process was always an open process. The environmental groups that were part of the work had a responsibility to inform the constituents and the general public about what was happening. There were public hearing and public meetings. She said that it was apparently that there were those who did not do their jobs because everyone was supposed to be informed about this project.

She said that she would like to address some of the earlier statements, such as the references to the 24 thousand dollars fund and the 7 million dollars. It’s very confusing to hear people give out incorrect information. Ms. Lewis said that President Obama had recently made some statements regarding closing down coal power plants. While everyone agrees that power plants

must close, her concern is that people understand that asthma is more than a disease. It often contributes to the economic devastation of families. It is the Number 1 cause of school absenteeism. She went on to explain that if a child had an asthma episode and could not go to school, one of the parents would have to stay home with the child, or take the child to the emergency room and that would impact their job. The parent is often forced to choose between their job and their child.

Ms. Lewis said that much hard work has been done to provide a plan that would be the best for the Bridgeport residents. The plan now calls for the project to be completed by 2021 rather than 2025, which is four less years of economic devastation.

Another thing was that the Coalition crafted a clause of the agreement that is the first in the nation that will assist the residents in obtaining jobs and having a monitor to make sure that the Bridgeport residents are assisted.

Ms. Lewis pointed out that energy plants are going to exist. People spoke about using alternatives. However, Connecticut is not geared for solar energy. According to Solar City, 75% of Connecticut does not qualify for solar power based on the various requirements such as having an owner occupied home with a south facing roof that is strong enough to support the solar panels and is clear of trees.

I'm against coal and natural gas plants because they contribute to global warming, are dirty, dangerous and even deadly. I'm against the Community Environmental Benefits Agreement with PSEG plans to operate the Bridgeport Coal Plant until 2021. They plan to build a natural gas plant now with an opening in 2019 and running indefinitely. This means for a period of two years, (2019-2021) PSEG will have both a coal and a gas plant running in Bridgeport.

There has been a lot of public discussion about the dangers of coal -- how it causes asthma related premature and hospitalization along with global warming due to coal and fine particulate emissions. Natural is just as dangerous to people's health and our climate.

Leaks of methane, the principal component of natural gas is far more potent at heating the atmosphere than carbon dioxide. Leaking gas is also bad for human health. Recently in a town near Los Angeles, California, there was a major gas leak. The whole town had to evacuate. If that happened in Bridgeport, to where would Bridgeport evacuate?

Closer to home, in Middletown, CT a few years ago, five people were killed and at least 12 were injured in a gas explosion at the new, under construction gas power plant. People within a 10 mile radius reported their houses shaking.

Natural gas is obtained through a process called fracking. They drill a deep well and inject millions of gallons of toxic fluid – a mix of water, sand and harsh chemicals at high pressure to

fracture rock to extract the natural gas that lies deep underneath. Fracking pollutes the water we drink and the air we breathe.

New York State has a moratorium on fracking. There is a global movement against the use of fossil fuels such as coal and gas in order to stop global warming. PSEG creates electricity using solar power in New Jersey, why not here in Bridgeport instead of coal and gas?

Say no to fossil fuels. Shut down the coal plant now. Block the building of a natural gas plant. Two million dollars is pennies for PSEG and nowhere near the worth of the health and safety of Bridgeport residents.

PSEG Agreement

Pastor Carl McCluster came forward and thanked Council Member Brantley for her patience in the previous meeting. He said that he had been first made aware of this a few years ago when he went to the library to hear a presentation. After that, he called PSEG and they called him back and invited him to tour the plant. He said that PSEG had meetings with the Council and members of the community along with the NRZ. This resulted in the formation of the Environmental Task Force that included Bridgeport citizens. For two and a half years, the group had public meetings on this topic. There were over 30 open meetings in the last year and a half. He said that the members of the community, including himself, were invited to participate and join. But now he is hearing something different.

Pastor McCluster said that it was very annoying that people would not come to the meeting and then be upset with the outcomes. Now that there is the possibility of money being paid out, people are upset.

The meeting was interrupted by a protester who claimed Rev. McCluster was lying. Council President McCarthy stated that the Council respects all viewpoints. When the protester continued to shout that he was being disrespected and was not being paid, Council President McCarthy asked that the protester be removed by Police Chief Gaudett. Council President McCarthy

repeated that the only way that the public speaking session worked was by extending respect to others.

Rev. McCluster spoke about how former Mayor Bloomberg got a significant payment for closing coal plants. He said that the plant will close in 2020. there are people who claim that the coal plant is causing asthma and pollution, but the figures that are being used are from all the coal plants combined. I-95 is the source of more pollution than the coal plant. Natural gas may not be the best possible alternative, but it is far better than coal. Global warming is not being caused by this plant. PSEG is not required to give the City anything because they are in full compliance with the State of CT DEEP. Both the Mayor and the attorney for PSEG agree that this is a good thing for Bridgeport.







WHEREAS, as a condition of the Contract of Sale, as per the two aforementioned City Council resolutions, the City was to deliver the Southern Property in broom-clean condition and the Developer was to demolish the Southern Property;

WHEREAS, the City applied for and received preliminary approval for an award of \$125,000 in hazardous materials (lead, asbestos) clean-up funding (the "Grant") from the US Environmental Protection Agency through Metro Cog, which funding the City wishes to use to clean up the Southern Property prior to the Developer's demolition work;

WHEREAS, it is a requirement of the Grant that title to the Southern Property be held by the City while the clean-up work is being done;

WHEREAS, the Developer is willing to give title back to the City at no cost to both the Northern and Southern Property or to the Combined Property as may be most applicable to Grant Requirements and as per the City Attorney's guidance in matters of title so that the City may receive and use the Grant so that the Project may proceed;

NOW THEREFORE, BE IT RESOLVED THAT the City is authorized to accept title at no cost to the Southern Property, the Northern Property, or the Combined Property, as the Grant may require and as the City Attorney shall direct for the express purpose of receiving and using the Grant per the purposes of the resolution; and that the City is further authorized to subsequently transfer title back to the Developer for no consideration, again for the Southern Property, Northern Property or Combined Property as required, so that the Project may proceed consistent with this resolution and with previous City Council actions in support of this Project.

RESOLVED FURTHER THAT the City Council authorizes the Director of OPED or his designee to take all other actions and do all other things in furtherance of and consistent with this resolution.

STATE LOBBYING SERVICES AGREEMENT

By this Agreement entered into on or about January 2016 between Reynolds Strategy Group, LLC (hereinafter referred to as "Consultant") and the City of Bridgeport (hereinafter referred to as "CITY"), the Parties agree as follows:

Scope of Work

Consultant will provide the following services:

1. Work with CITY officials on a needs assessment to identify priority interests and other areas of concern vis-à-vis the State of Connecticut (State). Review recent grant requests, funding status of projects and hold an in-depth discussion of potential funding opportunities. Develop a set of specific CITY objectives for State legislative sessions, including any reauthorizing legislation and any specific funding mechanisms for current projects.
2. Provide consultation to the CITY on potential funding available from, and contacts with the State government; particularly but not limited to, the Departments of Economic and Community Development (DECD), Department of Transportation (DOT), Department of Energy and Environmental Protection (DEEP), and Office of Policy and Management (OPM), as well as the Governor's Office and the various State Commissioners, as needed.
3. Develop with the CITY a set of specific State funding targets for projects, and monitor the activities to secure these targets.
4. Advise the CITY on how most effectively to work with the Connecticut Legislature and the staffs of the appropriate legislative committees to secure State appropriations and grants for projects of special interest to the CITY.
5. Assist in briefing the staffs of the State legislative Appropriations Committees and Bond Commission on the merits of appropriations for any funding requests for the CITY.
6. Assist in preparing and scheduling testimony, correspondence and written briefing materials by local officials in support of CITY legislation and requests initiated by the CITY or otherwise likely to impact the CITY's legal, financial, and/or operational interests.
7. Work with officials of the CITY and (upon the CITY's request) of non-profit agencies that apply for funds from the State government in order to have a coordinated listing of all requests and a managed plan to be successful in bringing additional funding to projects that will benefit the CITY.
8. Provide any additional consultation to the CITY on an as-needed basis. The Consultant shall advise, counsel, and represent the CITY in pursuing and opposing legislative initiatives and grant applications and awards at the State level in Hartford, CT and regional offices. The Consultant shall assist the CITY in preparing its State legislative, executive, and administrative agendas and shall strategize with the CITY on an ongoing basis as requested. The Consultant

shall identify topics and areas of need to State legislators serving the CITY, pertinent legislative leaders and committee chairs, and CITY Administrative officials.

The Consultant shall perform ministerial and discretionary functions, such as: prepare letters and verbal and written testimony; arrange and schedule appointments; monitor legislative, executive, and administrative activity; and communicate effectively with the CITY and its elected and appointed officials and their staff, as well as those interest groups identified by the CITY as sharing specific interests with the City, all in furtherance of the CITY's governmental agenda as determined by the City Administration.

Term of Contract

The term of the contract will be for the period commencing January, 2016 and ending on June 30, 2016.

The contract may be extended twice for two (2) consecutive one (1) fiscal year terms commencing July 1, 2016 and July 1, 2017, respectively by agreement of the Consultant and the CITY acting by and through its Mayor, provided funding has been appropriated for said purpose.

Cost of Services

The fee for the initial term will be \$55,000 total, payable in five (5) installments of \$11,000 each, due at the conclusion of each month from February, 2016 through June, 2016.

The fee for each of the two (2) extension terms, if exercised, will be negotiated by the Mayor and the Consultant, but will not exceed the amount to be budgeted for that purpose by the CITY Council, and will be due quarterly in arrears, on or about, September 30th, December 31st, March 31st, and June 30th annually.

In addition, there will be a charge for pre-approved direct expenses for travel, lodging, and meals during the initial term and the extension term.

Miscellaneous Provisions

A. *Confidentiality.* The Consultant will keep confidential all strategies and policies. Policies will not be presented to anyone in the private sector, government officials or the news media without the CITY'S prior approval.

B. *Conflicts.* The Consultant will not pursue objectives of other clients that conflict with the CITY objectives. Potential conflicts that arise will be immediately disclosed to the CITY and proper conflict avoidance measures undertaken.

C. *Governing Law.* This Agreement shall be governed by the laws of the STATE, both as to interpretation and performance.





Applications for such licenses shall be made in writing to the housing code enforcement officer upon such forms as may be prescribed by him. Such application, whether original or for renewal of a license already issued, shall contain in addition to such other information as may be required by the housing code enforcement officer, the applicant's name, address, the address at which he proposes to operate a rooming house, class I, a rooming house, class II, or a hotel, the number of rooms, roomers and beds to be for hire or not for hire, the number of beds and roomers in each room, and the name of the individual or individuals who will be charged with the control, management and maintenance of said rooming house, class I, rooming house, class II, or hotel. Application for the renewal of a license already issued shall be made to the housing code enforcement officer not later than one month prior to the date of expiration of the existing license.





No waste material of any kind shall be deposited upon any city dump during periods when it is closed; provided, however, that signs clearly indicting the hours during which the dump is closed must be posted at the entrance to the dump by the director of health and social services.

There is herewith established the Bridgeport Environmental Task Force for the purpose of providing technical assistance and advice to the City as to support collaborative efforts to work with public and private sector and non-profit initiatives for environmental Issues that impact the City, with special emphasis on the Black Rock, West Side/West End, South End or East End NRZ areas.

Section 2.124.020 Rights, powers, duties and responsibilities.

The Environmental Task Force shall have all the rights, powers, duties and responsibilities to advise the City and any fiduciary of a Community Environmental Benefits Fund, if any, on environmental issues, including, but not limited to, rainwater/sewage mix; sustainability as it relates to energy usage; financial and legislative issues and incentives; power plants in the City; environmental health survey – to measure outcomes; review any operating, policy and energy efficiency programs that may be included in a Community Environmental Benefits Agreement, if any; and, the allocation of the Community Environmental Benefits Fund, if any, that may be negotiated and funded in accordance with the provisions of the Environmental Justice Community Act. Unless otherwise authorized by state law the Task Force shall have no regulatory authority.

Section 2.124.030 Members and terms.

A. The Environmental Task Force shall consist of fifteen (15) members appointed from the following groups and in the following fashion:

1. Chair (or designee) of the Black Rock NRZ Planning Committee;
2. Chair (or designee) of the West Side/West End NRZ Planning Committee;

4. Chair (or designee) of the East End NRZ Committee;
5. Chair (or designee) of the Energy Improvement District;
6. The Director of Health & Social Services or a successor department;
7. Seven (7) members appointed by the Mayor, subject to confirmation by the City Council:
 - a. Two (2) At-Large residents nominated by the City-wide NRZ;
 - b. Two (2) representatives of the environmental community nominated by the Healthy CT Alliance or a successor organization;

The mayor shall be a member ex officio and may vote only in case of a tie.

- B. Such appointees of the mayor, in section A.6, above, shall be appointed to serve for a term of three (3) years except that initial appointments shall have staggered terms so that two members shall serve for one year, two members shall serve for two years and three members shall serve for three years; such terms shall be set forth at the time of the appointment by the mayor.

- C. Any vacancy in the membership of this Environmental Task Force shall be filled for the unexpired portion of the term in accordance with the method of appointment as set forth, above. Any member appointed by the mayor may be removed by the mayor for cause and, on request of such member, after public hearing. Members of the Environmental Task Force shall receive no compensation for their services as such, but shall be reimbursed for their necessary expenses incurred in the performance of their official duties.

Section 2.124.040 Other Duties.

The Environmental Task Force, in addition to its duties, shall particularly seek to coordinate the activities of and cooperate with official and unofficial bodies organized to promote the purposes set forth herein and to assign and delegate to these official and unofficial agencies those functions which are most appropriate to their capacities.

Section 2.124.050 Report and Recommendations.

The Environmental Task Force shall annually prepare and transmit to the mayor and common council a report of its activities and of its recommendations regarding environmental issues.

COMMUNITY ENVIRONMENTAL BENEFIT AGREEMENT

This Community Environmental Benefit Agreement (the "Agreement") is entered into as of February __, 2016 ("Effective Date") by and among PSEG Power Connecticut LLC, a limited liability company with a place of business at 1 Atlantic Street, Bridgeport, Connecticut ("PSEG"), the City of Bridgeport, a political subdivision of the State of Connecticut with its principal place of business at 999 Broad Street, Bridgeport, Connecticut ("City"), _____, a community organization with an office at 000 ____ Street, Bridgeport, Connecticut ("____"), _____, a non-profit organization with a principal place of business located at _____ St. __, __ Floor, _____, __ 00000 ("____"), and _____, an operating unit of _____, with a principal place of business located at 000 ____ St., Suite 210, Hartford, CT ("_____"). _____, _____ and _____ are collectively referred to herein as "Community Groups," and, with PSEG and the City, all herein are referred to as the "Parties."

WITNESSETH

WHEREAS, PSEG is proposing to install and operate a combined cycle facility (the "Facility" or "Project") with a wholesale electric generating capacity of approximately 470 megawatts ("MW") at the site (the "Site") of its existing Bridgeport Harbor Station ("BHS") located at 1 Atlantic Street in Bridgeport, Connecticut, provided that the Facility is awarded a capacity obligation in the upcoming forward capacity auction to be conducted by the regional grid operator, ISO-New England ("ISO-NE") in February, 2016 (the "2016 ISO-NE Auction");

WHEREAS, this Agreement has been negotiated under the auspices of the Environmental Justice Act, which allows for such agreements to encourage developers of

affecting facilities and community groups to work together to address and mitigate potential environmental impacts from such affecting facilities;

WHEREAS, PSEG intends to submit a Petition for Declaratory Ruling (the "Petition") to the Connecticut Siting Council (the "Siting Council") for siting approval to develop and operate the Project at the Site; and,

WHEREAS, the terms of this Agreement meet the multiple concerns of the parties as well as the objectives of the Environmental Justice Act.

NOW THEREFORE, in consideration of the mutual promises contained herein, and for other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the Parties hereto agree for themselves, their successors and assigns as follows:

1. **Preamble**. The above recitations are true and correct, and are incorporated herein by reference.

2. **Establishment of the Community Environmental Benefit Fund ("CEBF")**.

(a) **Creation of the CEBF**. Upon satisfaction of the Conditions Precedent set forth in Section 2(b) below, PSEG or its designee shall contribute the amount of Two Million and 00/100 (\$2,000,000.00) Dollars to a designated interest bearing fund managed by Fairfield County's Community Foundation or other similar established charitable organization or entity (the "Designated Organization") recommended by the Environmental Task Force of the City, subject to the approval of PSEG, which approval shall not be unreasonably withheld.

(b) **Conditions Precedent to CEBF Funding**. The CEBF shall be funded in the amount set forth in Section 2(a) above, within thirty (30) calendar days after: (i) The Facility being awarded a capacity obligation in the 2016 ISO-NE Auction; and (ii) PSEG has received and found acceptable in its discretion each of the final, non-appealable (i.e. after applicable appeal periods have lapsed) approvals and permits (the "Permits") required for the Project

Bridgeport/PSEG Community Environmental Benefits Agreement - 4

(attached as **Schedule B** is the complete list of all required Permits), including the (a) Siting Council's approval of the Petition; (b) CT DEEP's Air Permit for the Project (including, issuance of the Air Permit); and (c) issuance of all other applicable local, state and federal permits and approvals, including the Coastal Site Plan Review (collectively, the "Final Permits"). In the event that a non-signatory to this Agreement intervenes or opposes the Permits or undertakes an appeal or other litigation against PSEG in respect of the issuance of the Permits, the City will work with PSEG in good faith to assist PSEG in obtaining the Final Permits as soon as possible, including intervening in PSEG's behalf in applicable administrative or legal proceedings.

(c) **Operation of CEBF.** Upon the establishment of the CEBF with PSEG funding as provided for in Section 2(b) above and subject to the terms of a fund agreement, the Designated Organization shall have the authority to withdraw from such account, following consultation with the ETF regarding their recommendations. The ETF shall negotiate the funding agreement with the Designated Organization, subject to PSEG's right to prior review and comment. The CEBF shall be utilized for the public benefit and shall not be political in nature. The funding agreement shall include provisions to encourage the Designated Organization, the City and the ETF to seek and apply for additional funding as available from governmental, quasi-governmental, and charitable entities and institutions and other programs to increase or supplement the funds available for the purposes stated therein and described above. Furthermore, the funding agreement will establish the procedures and standards for selecting acceptable projects and distributing funds.

(d) **Purposes of CEBF.** At the outset, the Designated Organization shall create and engage in two distinctive funding opportunities: open competitive funding opportunities for organizations serving the City and for particular departments of the City. These programs shall advance the intents and purposes underlying the adoption of the Environmental Justice Act including, but not limited to, achieving maximum public health and environmental benefit for the air quality in the neighborhoods surrounding BHS. The Parties agree that there are a number of

organizations and initiatives in the City that will contribute to the long-term public benefit and well being of the community addressing health and environmental needs relating to infrastructure, health services, outreach, education and energy efficiency as were set forth in the CAC Report. There are City departments and other public entities that are currently providing health and environmental services. The following departments may apply and compete for leveraged funding, subject to strict rules of accountability as shall be developed by the Designated Organization: Health Department, Board of Education, Energy Improvement District, Planning and Economic Development, Youth programs and the Small and Minority Business Enterprise program.

(e) **Renewable Energy Investment Program**: Commencing on the Effective Date PSEG will initiate a program for the purpose of investing, at least, \$5 million for renewable energy investment opportunities located in the City that are: recommended by the City and/or ETF (ideally with the support of the Connecticut Green Bank); and, approved by PSEG taking into account PSEG's investment guidelines that are developed in cooperation with the City and/or ETF. PSEG encourages the City and Community Groups to refer such renewable energy investment opportunities to PSEG's Community Liaison Officer who will (i) advise them on criteria for compliance with the investment guidelines and will then (ii) bring the same to PSEG for further review and consideration. Whether a renewable energy investment opportunity will meet the agreed-upon investment guidelines and customary due diligence is satisfied is in PSEG's sole discretion and, if so, whether an actual investment transaction can be consummated will depend on the ability of PSEG and project counter-parties to negotiate mutually agreeable terms and to obtain regulatory approvals, among other contingencies. Unless specifically requested by the City and/or ETF, the investments made pursuant to this paragraph shall not be intended for use on the BHS property.

3. **Permit Issuance.**

(a) Material Changes. The Parties agree that any change to the representations contained in the Baseline Documents will not be deemed a material change unless the CT DEEP, in the case of the Air Permit Application, or the Siting Council, in the case of the Municipal Consultation and Petition process, deems such change (i) to be significant enough as to require a reset or restart of the applicable Air Permit Application or Petition process or (ii) would result in a significant increase in adverse environmental effects from the Facility (a “Material Change”).

(b) Representations and Understandings Pertaining to Air Permits.

(1) Air Permit Application. PSEG represents that the Air Permit Application includes all of the material terms, conditions and elements of such application as of the date of this Agreement. The Parties acknowledge that PSEG may revise the Air Permit Application from time to time to provide information requested by CT DEEP or as needed to meet changing Air Permit Application requirements, such as revised air modeling standards and procedures or to update CT DEEP on changed equipment manufacturers’ specifications. Contemporaneously with any such updates to the Air Permit Application, PSEG will use reasonable efforts to notify the City and Community Groups of the public availability of same. The City and Community Groups have read and reviewed such Air Permit Application. PSEG agrees that it will not undertake a Material Change in the Air Permit Application, as amended from time to time, without first consulting with the City and Community Groups and explaining the need for such changes.

(2) Title IV and Title V Permits. As indicated on Schedule B, PSEG also expects to file for Clean Air Interstate Rule (“CAIR”) and Acid Rain Permits and a non-minor modification of the existing Title V Air permit for BHS (to add the new Project to the existing inventory of air emissions sources at BHS) for the Project as described in the Baseline Documents. PSEG agrees that in applying for these additional air permits, it

will not seek approval for the Project that represents a Material Change in the Project as described in the Baseline Documents.

(c) Representations and Understandings Pertaining to the Petition. PSEG represents that the Municipal Consultation includes all the material terms, conditions and elements that will be contained in the Petition. PSEG may also submit one or more filings with the Siting Council known as exempt modifications that may or may not be related directly to part of the Project. PSEG agrees that its Petition will not seek approval for the Project that represents a Material Change in the Project as described in the Municipal Consultation.

(d) City's Agreement to Support the Project. As long as PSEG does not initiate a Material Change to the Project, the City agrees to express its support for the Project as set forth herein and in the Baseline Documents, including filing a public letter with the CT DEEP in the Air Permit Application administrative record and with the Siting Council in the Petition administrative record. While respecting the independence of or not unduly interfering with the judgment of the other regulatory authorities responsible for issuing the Permits, the City will use its reasonable efforts to convey its support for the Project.

(e) Community Groups Agree Not to Oppose the Project. The Community Groups have read and reviewed the Baseline Documents and such other materials as they deem appropriate. So long as PSEG does not initiate a Material Change to the Project, the Community Groups agree: (1) not to oppose any issuance of the Permits; (2) not to intervene in any process or proceeding to oppose the Project including but not limited to CT DEEP (in connection with the Air Permit Application) or the Siting Council (in connection with the Petition); and, (3) not to intervene or submit a document in opposition in any other proceeding in which intervention or public input is sought or permitted, or before any state or federal court seeking any relief whatsoever in opposition to the Project. The Parties agree that there is no exception or limitation to the commitment of the Community Groups not to oppose the Project or issuance of any Permit

for the Project for any reason in any local, state or federal executive, legislative or judicial forum provided PSEG does not initiate a Material Change to the Project.

4. **Other PSEG Commitments.**

Provided that the Conditions Precedent and Caveats set forth in Section 5(a) are satisfied, PSEG agrees to the following additional commitments:

(a) **Bridgeport Harbor Station Unit #3.** BHS Unit # 3 shall not participate in ISO-NE capacity auctions that result in capacity obligations in the ISO-NE markets past the capacity year that begins on June 1, 2020, provided that all of Unit #3's commercial operations will cease no later than July 1, 2021 (the "Unit #3 Retirement Date").

(b) **Joint City/PSEG Planning Study.** PSEG and City shall jointly participate in a site planning study to be funded at least partially from the CEBF (City will attempt to attract additional philanthropic support) to explore ways in which PSEG's redevelopment or reuse of the remainder of its property – not occupied by the Project or other BHS Facility with ongoing operations can reinforce City and Community objectives for the South End and environs. This study will have two components: (1) it will examine near term deconstruction, remediation, landscaping, and/or interim options to maximize positive impacts to the Community and minimize negative aesthetic impacts of the decommissioned Unit #3 and it is expected that a negotiation between PSEG, the City and ETF will occur at the completion of this stage of the study to determine the minimum amount of work in accordance with that plan to be conducted by PSEG within a set timeframe; and, (2) it will explore medium- and long-term redevelopment or reuse options for the site with specific focus on ways in which the remainder of the parcel can support the City's coastal resiliency, mobility, waterfront access, and job creation objectives recognizing that any redevelopment or reuse of the site will depend on economic viability of that use.

(c) **Community Liaison Officer**. PSEG shall designate a Community Liaison Officer as a point of contact for the City and Community Groups. The initial Community Liaison Officer will be Neil Brown, Manager of External Affairs. The Community Liaison Officer shall establish a communications plan to facilitate communications between PSEG and the local community. Such plan will provide for but not be limited to: (1) the posting of public information regarding the Project and BHS on its website; (2) participating in community meeting(s), in which each of the signatories to this Agreement are invited prior to the commencement of commercial operations at which PSEG will describe its emergency action plan and communications plan; (3) providing notification to the signatories of any application to the CT DEEP or Siting Council for approval of a change in ownership or control of the Project; (4) PSEG's participation during at least the first five years (and thereafter upon request of the City and Community Groups) in a meeting on an annual basis for the purpose of updating the City and Community Groups on any issues related to the operation and maintenance of Bridgeport Harbor Station and the Project; and (5) the establishment of a hotline and email address through which questions or concerns can be submitted to the Community Liaison Officer. In addition, on or before ninety (90) days after commencement of commercial operations of the Project, PSEG shall provide a tour of the new Facility and invite the Community Groups to attend, provided that all tour attendees shall comply fully with all security and safety procedures required by PSEG and such attendees would not otherwise cause PSEG to violate applicable laws including applicable export control regulations or federal homeland security requirements.

(d) **2016 Regional Greenhouse Gas Initiative ("RGGI")**. As part of the 2016 RGGI program review, PSEG agrees to publicly support extension of the RGGI cap on regionwide greenhouse gas emissions from power plants. As it relates to Connecticut, PSEG will support a cap that is consistent with the state of Connecticut's 2030 greenhouse gas reduction goals, as identified in the Conference of New England Governors and Eastern Canadian Premiers' August 31, 2015 Resolution Concerning Climate Change (Resolution 39-1).

PSEG will demonstrate its public support for this 2030 cap by, at a minimum, submitting written comments to the RGGI board, and to appropriate Connecticut state agencies, on behalf of PSEG during formal comment opportunities.

(e) **Ongoing Emission Reduction Discussions.** PSEG agrees to engage in further discussions with the City and Community Groups regarding statutory, regulatory and/or consensual efforts with respect to the operating protocols designed to maximize efforts to contribute to the regional goals and objectives of the GWSA. The ETF shall convene and serve as the facilitator of such ongoing dialogue.

(f) **Commitment to Support Local Hiring.** PSEG is committed to constructing the Project using qualified regional contractors, to work cooperatively with local building trades unions, the City, ETF and Community Groups to identify and qualify subcontractors and laborers, including minorities, woman and veterans as well as construction firms owned by the same, with a preference for Bridgeport residents and businesses. PSEG and its contractors shall further adhere to the “good faith efforts” as defined in Chapter 3.12.130 (G) (5) (the “Mandatory Good Faith Efforts”) of the Bridgeport Code of Ordinances for applicable portions of the Project work excluding equipment and components. While Chapter 3.12 *et seq.* of the Bridgeport Code of Ordinances is not otherwise applicable to the Project, PSEG agrees to comply with the Mandatory Good Faith Efforts as provided in the first sentence of this sub-section (f) and will establish on-going dialogue and work with local unions in support of efforts to include Bridgeport residents in apprenticeship programs and to maximize efforts in that regard and with respect to hiring workers qualified by such programs or prior experience for general employment in the building trades for the duration of the construction of the Project. In furtherance of such commitment PSEG shall work with the City and the ETF to identify and retain a mutually agreed upon facilitator to develop an action plan to effectuate and monitor the commitment set forth herein pertaining to the hiring and retention of minorities, woman, veterans and/or their businesses as the case may be.

5. **Conditions Precedent and Caveats.**

(a) The Parties acknowledge that PSEG's commitment to fund the CEBF and Other PSEG Commitments set forth in Section 4 above are contingent on (i) PSEG obtaining an award of a capacity obligation for the Project in the upcoming 2016 ISO-NE Auction or a subsequent forward capacity auction, and (ii) PSEG obtaining the Final Permits as set forth in Section 2(b) of this Agreement.

(b) The Parties further acknowledge and agree that the commitments set forth in Section 3(d) and (e), above, by the City and the Community Groups in this Agreement are not contingent upon PSEG funding the CEBF.

(c) The Parties further acknowledge that the provisions of Section 2(e) shall be in full force and effective on the Effective Date of this Agreement.

6. **Notice**

7. **Entire Agreement.** It is understood and agreed that this Agreement and other documents contemplated herein constitute the entire agreement between the Parties, and no oral statements or promises, and no understandings not included in this writing, shall be valid or binding.

8. **Counterparts.** This Agreement may be executed in counterparts, or any number of duplicate originals, all of which shall constitute one and the same instrument. The Parties further agree that the execution of facsimile copies of this Agreement, as well as faxed or electronic signatures, shall be valid with the same effect as originals.

9. **Good Faith Covenant.** The Parties agree that their actions and dealings with each other shall be subject to an express covenant of good faith and fair dealing.

10. **Severability.** The Parties agree that if any provision of this Agreement is declared or determined to be illegal, invalid or unenforceable, the remaining parts, terms and provisions shall not be affected, and the illegal, invalid or unenforceable provision shall not apply.

11. **Headings.** The paragraph headings herein are for the convenience of reference only, and shall not limit or otherwise affect in any way the meaning or interpretation of this Agreement.

12. **Effective Date.** The Effective Date shall have the meaning set forth in the Preamble.

13. **Governing Law and Venue.** This Agreement shall be governed by and construed in accordance with the domestic law of the State of Connecticut without giving effect to any choice of law provision or rule (whether of the State of Connecticut or any other jurisdiction) that would cause the application of the law of any jurisdiction other than the State of Connecticut. In the event of any dispute between the Parties, the Parties agree that, subject to the dispute resolution procedures set forth in Section 14, venue shall lie only in the State and Federal courts located in Bridgeport, Connecticut. Service of process may be made in any matter recognized by such courts. Each of the Parties waives its right to any jury trial with respect to any litigation arising under or in connection with this Agreement.

14. **Default, Dispute Resolution and Remedies.**

(a) **Default.** Any Party that is a signatory to this agreement (“Aggrieved Party”) shall have the right to give written notice to another Party (“Noticed Party”) that the Noticed Party is not performing in accordance with the terms and conditions of this Agreement. (For purposes of this Section 14, the Aggrieved Party and Noticed Party are collectively referred to as the “Disputing Parties”.) Such notice shall describe with specificity the basis for the Aggrieved Party’s belief and may describe the recommended options to correct the failure.

(b) **Response.** If the Noticed Party agrees with the Aggrieved Party’s concern, the Noticed Party shall promptly take appropriate action to correct the failure. In such circumstance, the Noticed Party shall respond to the Aggrieved Party’s written notice within ten (10) calendar days of receipt thereof describing the action taken in response to the notice.

(c) **Resolution of Dispute.** If the Noticed Party disagrees with the Aggrieved Party’s concern, the Disputing Parties shall each designate a member or members of its executive management to discuss the matter and attempt to resolve the dispute. (In the case of PSEG, this will be the PSEG President and, in the case of the City, this will be the Mayor.) The representatives of the Disputing Parties shall meet in a Bridgeport location mutually agreed upon

within twenty (20) calendar days of receipt of the Aggrieved Party's written notice. The Disputing Parties agree to use their good faith efforts to settle promptly any disputes or claims arising out of or related to this Agreement through their respective representatives and shall negotiate in good faith to resolve the dispute. All negotiations and discussions pursuant to this Section 14(c) shall be confidential and shall be treated as compromise and settlement negotiations for purposes of Federal Rule of Evidence 408 and applicable Connecticut state rules of evidence. If at any time either Party believes that continued discussions will not result in a resolution of the dispute, then such Disputing Party may pursue its rights and remedies at law in the manner described in Section 13.

(d) **Tolling Statute of Limitations.** All applicable statutes of limitation and defenses based upon the passage of time and similar contractual limitations shall be tolled while the discussions specified in this Article 14 are pending. The Disputing Parties will take such action, if any, required to effectuate such tolling. Without prejudice to the procedures specified in this Article 14, a Disputing Party may file a complaint for statute of limitations purposes if in its sole judgment it deems that such action may be necessary to preserve its claims or defenses. Notwithstanding such action, the Disputing Parties will continue to participate in good faith in the procedures specified in this Article 14.

8. Soil Erosion and Sediment Control, and stormwater management authorizations (City of Bridgeport Engineering office) and related DEEP approvals, as necessary for both construction and operations

9. United States Army Corps of Engineers (USACE) Individual or Nationwide Permit(s) and Connecticut DEEP Bureau of Water Protection & Land Reuse – Office of Long Island Sound Programs (for stormwater outfall(s) and any shoreline impacts)
