1. Application 2015-03 by Parsons Brinckerhoff, c/o Steven George, P.E.- bridge superstructure replacement, repair of existing abutments and replacement of the NW, NE and SE wingwalls along the Rooster River at Capitol Avenue Bridge over Rooster River Overflow.

Mr. Matthew Popp stated that the intention of the application is to repair the bridge over Capitol Avenue, originally built in 1907 and last repaired in 1984. He stated that it involved 1300 square feet of wetlands.

The Chair asked if the repairs were mandatory, and Mr. Popp answered in the affirmative. The Chair stated that as the bridge was already in existence, and thus the land was already disturbed, he did not think it would require a public hearing.

Commissioner Freddino asked if the houses on either side had been notified. Mr. John Requidy, city engineer, stated that they were in the preliminary stages of design, and that the abutters will be notified by formal process.
