77-20 Proposed Resolution Accepting Gift of Grant-Funded Bicycle Rack from Metropolitan Council of Governments.

Ms. Haig, the Director of Planning then introduced Mr. Robison, the City Planner to discuss Plan Bridgeport's alternative modes of transportation. There is a Grant from the Connecticut DOT for bike trails. The Design plan focuses on safety.

Ms. Haig asked Jacob Robinson to explain the purpose of the grant. Mr. Robison informed the Committee of the City's plan to increase the mode of transportation and OPED is in support of the Bike Plan. Mr. Robison went on to say the City along with surrounding cities applied for this grant with the Department of Transportation to cover several bike stands throughout the city in

and the grant is for \$1,924.00.

Mr. Robison displayed a picture of the city showing where the racks would be placed

Throughout the city the map also listed the various sides of town in which the racks would be

placed.

Council Member Herron asked why were there no racks on North End since there are several

places where people gather.

Council Member Scott Burns asked how dark fiber is installed in the streets. Ms. Haig stated the

City will be looking in addressing dark fiber.

Council Member Michelle Lyons agreed with Council Member Herron that the North End

should have this and expressed her dissatisfaction with the plan as it was presented to the

Committee. She stated she was unhappy with the proposal as there are parks, schools & a

university in the north end and residents there also ride bikes.

Council Member McCarthy asked where the scooters were located and if they needed racks.

Mr. Robinson explained that the scooter program is having some cost issues and noted that they

do not require racks for storage.

Council Member Roman-Christy informed Ms. Haig that she would also like racks in her part of

the North End as well.

Council Member Herron asked that the item be tabled until there are some additional funds to

add racks on the North End.

Ms. Haig stated it was important this item passed now due to time constraints in availability of

the grant.

Council Member Brantley asked if the committee would vote on the item so that the City would

not lose any funding. An amendment could be added that OPED can revisit the request for

additional racks in the North End.

The entire Committee agreed that bike racks should be equally distributed throughout the city.

Ms. Haig informed the Committee that it was not OPED'S decision to select various parts of town, however they were just trying to keep in compliance with the grant regulations which focuses on the underserved communities throughout the City that would utilize bikes as a mode of transportation more so than other areas of the City.

The Committee still agreed that all of the communities consist of people who are underserved and who also ride bikes as a mode of transportation.

Ms. Haig asked Council Member Herron about the source of funding for the racks. Council Member Herron suggested that her department look for additional funds.
