WHEREAS, the schedule of events currently includes a variety of opportunities throughout the city of Bridgeport to bring thousands of our youth community together in a safe, positive and productive manner with a "Peace Day Festival" culmination at Seaside Park to include a Sports for Peace Walk, Rally, Sports, Music, Food, Live Entertainment and Community Peace Festival; and

WHEREAS, the Mayor, Board of Education, Bridgeport Police Department, Bridgeport Fire Department, Public Facilities Department and any and all other public agencies are strongly urged to work in collaboration with the organizers of "Peace Week" to ensure the events are supported, successful and safe for all those in attendance; and

CITY Fiscal Decisions: Finished Where? John Marshall Lee

CC: It is time again to look at the needs of the community of Bridgeport, to assess how all of our citizens are helped in meeting their needs by public programs, and to direct tax money for operations and for capital projects by authorization of our elected Mayor and City Council. It is called 'Budget Review'. How many folks have access to the facts basic to this annual assessment, understand whether recent dollars have been well spent, and provided with time or opportunity to learn, question, and genuinely participate? Bridgeport taxpayers are not part of a rational customer-centered system, but rather are disciplined to accept the decisions of a few, having to trust that some 'common good' is served.

During the past year the annual process for the spending of \$600 Million Federal, State, and local dollars increased in one respect: the allocation of \$110 Million Federal ARP funds over a three-year period was organized into several areas of grant focus, with members of the community forming evaluation panels to assess and vote on distribution, and then leave the City to administer. So far, so good, though current reporting of the what and the how of grant delivery by multiple organizations is incomplete.

But it is interesting to note that there remains a balance of funds to be spent. Why are the people of the City not participating directly in this final or ultimate distribution? When there are three challengers to the incumbent, it is obvious there are many issues floating in the community (besides the reduction of taxes, short and long term) that need to be heard. How can the community at large participate in such decision making and be met by respectful listening by those who are elected and have the decision-making power at this time?

The operating budget shows the current employment plan for the City. But in recent months there has been talk of a "new plan" but details have been scarce, or non-existent. When it comes to appointments with scant notice to the public, at considerable compensation for a potential employee currently requiring certification, it appears to be rushed. Is there an overall plan on paper? Can it be studied as part of the larger budget picture? Does it make sense? (4-17-23)

And 800 City owned properties? How much value is shown by the Assessor? And occupying how much City acreage? Public answers? Time will tell.

The Council Members should stop talking about things that they don't understand.
