WPCA foreclosures and state bonds.

Mr. Book came forward and wished everyone a Happy New Year. He then spoke about his recent campaign for office and sent emails to all the City Council Members. He said that at one point, his email account was attacked and thought it was possibly done by the Russians.

Mr. Book then went on to speak about the WPCA foreclosures and a series of emails from Mr. Epstein to Atty. Liskov. He said that in 2009, Atty. Epstein had tacked on a \$2,000 fee for doing virtually nothing when he was involved in a payment plan for a WPCA tax lien. This type of additional charge happened a number of times to different residents and later this practice was investigated. Since then, when clients complains to Mr. Book, he contacts Atty. Epstein and Atty. Epstein reduces the amount but continues to tack on this fee with all the cases he handles.

Mr. Book also spoke about a recent episode involving State Representative Steve Stafstrom who spoke about some State grant funding that he termed as "free money". There is no such thing as a free lunch. He also pointed out that State Representative Stafstrom was also employed by the same firm that was the bond counsel for the City.

New Year City Finances.

On Sunday January 1, 2017, the CT Post had a lengthy "news" article that allowed Mayor Ganim to speculate on his 13th year of "Bridgeport leadership" and to provide a 'selfie' grade of B+. I get neither the time nor space to share my public thoughts, so, in quick order:

Mayor Joe is a "second chance" candidate because many people who know a lot about the need for added chances trusted him to be different than the "pay to play" felonies of which he was found guilty, was sentenced, and served 7 years away from family and Bridgeport. Joe tells us in that article that he is "accountable" but he has not told us where he resides. That question has been percolating for months now. During the holidays I heard from a person at Cartright St and another on Ellsworth St, each rumored locations for the Mayor's home that he has not been seen for months in either place. This is not a case of contacting the Police Department and making a "missing person" report.

However, if he does not reside in Bridgeport, he would be guilty of an F, for 'faking' it or 'fooling' most of the people because the Charter calls for him to reside in the City. Better that we have a proactive Ordinance that he and all municipal public servants adhere to.

I submit a Resolution for consideration by your Ordinance Committee at their next meeting. There have been one or more questions in recent years regarding Council and/or Commission or Board out of City or district residence. This Ordinance has no expense and is but one step up on an ethical stairway to assure the public of a qualification for holding office.

RESOLUTION regarding Residency Reporting:

Whereas it is important to the State of CT to have on hand the residence of motor vehicle operators according to the "notification within 48 hours of address change" official requirement.....

Whereas it is at least equally important for Bridgeport citizens to trust that each locally elected, mayorally appointed, and/or City Council approved official resides with the City and district appropriately, as indicated by the City Charter.....

And whereas such information is regularly provided on the site of comparable CT municipalities for all to see as an honest requirement for public servants to show respect for open, accountable, transparent and honest reporting.....

Therefore, be it resolved that all municipal elected officials including the Mayor, City Council members, as well as Board and Commission members appointed by the Bridgeport Mayor provide their current residence street address of record to the Town Clerk's office by January 31, 2017. In the future, notice of such current residence address shall be provided to the Town Clerk's office within 30 days of such change or at least affirmed or changed annually before the end of January while such public service is pursued.

Council Member Brantley joined the meeting at 6:53 p.m.

I look forward to one or more of you to submit such a Resolution to the Ordinance Committee for its fair and substantial review and consideration. There is yet time in the month of January on your meeting two weeks from now, for me to provide an opinion on whether a B+ grading is due Mayor Ganim regarding his performance in 2016. Will you assist the sense of the Resolution see the light of day? Time will tell.

Mr. Young came forward ad knelt down to plead with the Council Members in order to support two black delegates. He said that he had spoken with the Chief of Police, A. J. Perez about the situation. He spoke about State legislation that addresses youth services in inner cities. He encouraged people to write in to their representatives about this issue. He said that the juvenile jail downtown should be shut down and it was a bureaucratic nightmare. The building could be used for youth services. By closing the downtown juvenile jail, the City might be able to provide more funding for the schools. The City should choose Yale over Jail.

A Resolution by the Bridgeport City Council Authorizing the City to Receive Brownfields Grant Funding in Support of The Anaerobic Digester Project

WHEREAS at its meeting of February 29, 2016, the Bridgeport City Council adopted Resolution Item #36-15 authorizing the City to apply to the State of Connecticut Department of Economic and Community Development (DECD) for up to \$1,984,050 in Brownfields Grant Funding (the "Grant") to perform environmental remediation work at the WPCA plant on Bostwick Avenue in support of the Anaerobic Digester Project;

WHEREAS, pursuant to the City's application for such funding, the State DECD ultimately awarded the City a \$2,000,000 Grant, which is \$15,050 more than the amount authorized by Resolution Item #36-15;

WHEREAS, there is no local match requirement associated with this Grant;

WHEREAS, the City wishes to receive the full \$2,000,000 Grant;

NOW THEREFORE, BE IT RESOLVED

- 1) That the City is authorized to receive the full \$2,000,000 Grant awarded to it by the State DECD.
- 2) That the Mayor or the Director of the City's Office of Planning and Economic Development (OPED) is authorized to execute any and all contracts associated with the City's receipt and use of the Grant, and, provided that there continues to be no local match requirement, is likewise authorized to execute any subsequent amendments to such contracts, including contracts that would increase the Grant funding, and to execute any related documents as may be necessary to administer this Grant funding and the Anaerobic Digester Project that it supports.
