John Marshall Lee 30 Beacon Street Bridgeport, CT 06605 City Finances.

Mr. Lee read the following statement into the record:

Council members, are pensions and bonding difficult subjects for you? Let's get basic. Bonding may seem simpler. Works like a home mortgage. Principal? Term of years? And guaranteed interest rate? Now, pensions. Employees work. Then they retire expecting a promised

guaranteed income from the City. Income is based on enough funds earned on pension assets. For years Bridgeport employees have trusted Municipal Employee Retirement System which the State manages but makes no contributions to. This year MERS reported a "past service liability". First the CAFR said \$31Million was due. Now the Mayor says \$90 Million will settle the deal with no more money ever. But CAFR shows when assumed earnings are decreased, liabilities increase. And it does not show \$90 Million!!!

Labor Relations Department negotiates contracts for the City Police and Fire came to terms with overdue contract renewals. Labor Relations handled all the details that importantly included shutting down Pension B Plans and transferring active personnel to MERS. Most of Plan B assets transferred to MERS. The City was current with contributions.

MERS requires more trust assets to fund actuarial past service liability that Bridgeport became obligated to in the 2012-16 contract. Does anyone present know the price tag of that obligation? In other words, what did that contract cost the City for the terms agreed to? If the City had no MERS past service liability before 2015 but has one in 2016 why else look anywhere other than including public safety overtime earnings?

The \$90 Million requested for bonding by Ganim's "concept" eliminates past service liability? Like this small box, nice and neat with no more payments for liabilities ever despite investment earnings? Or do we face \$270 Million if actuaries reduce the assumed earnings rate to 7% (as was done with Ganim's first pension bond deal Plan A recently)? Or is the liability represented by the big box at over half a billion dollars when the liabilities of Plan A and MERS are considered. (Remember that the 2000 bond deal has the City paying \$900 Million for the privilege of borrowing \$350 Million as well as NOW contributing tens of millions when the trust portfolio at \$60 Million disappears. Looked at today, a good deal? As advertised or expected?) It depends on added contributions from the City, which were often reduced and deferred. It depended on earnings at 8% to come true. Plans like Plan B and MERS have been earning less than 5% on average. So liability INCREASES each year into the future.

The Mayor talks about saving 4% of \$90 Million bond interest expense payable or \$3.6 Million per year. But since MERS does not agree that all past service liabilities are forever funded in full, then the savings really disappears and bonding interest of \$100 Million becomes an extra expense.

As the trust earns less than assumed, City liability increases, and more taxpayer contributions are required.

What was the cost to transfer from Plan B to MERS based on actual realistic rates of return (5% assumption) in the market place? Will Labor Relations show you the calculations now? Were they shown to CC and made public previously? Were they secret then and now?

Perhaps a re-negotiation is in order? Normal retirement requires 25 years. Rights to and funding of such overtime earnings have been part of formulas for merely five years. Adjustments may be possible to help the taxpayer in this poor City as both Mayor Finch and Mayor Ganim have stated when they have gone to Hartford routinely request the cost of our obligations be kicked down the road. What did taxpayers gain from the MERS transfer?

Vote NO on the pension bonding resolution until you can show voters the total cost to taxpayers of the move from Plan B pensions to MERS assuming that our earnings continue at the average rate of the past ten years?

In the meantime pay MERS one of the schemes they have offered to the City. We will not have a \$4 Million surplus every year as we do this year.

Bonding and bond interest as suggested by the Mayor is unnecessary expense. \$100 Million extra interest over 28 years to borrow \$90 Million. MERS is not demanding a lump sum today. And a lump sum payment to them will likely continue low returns and market losses as we have seen in Ganim's existing Plan A. Which box to fund? How much is required? Know the amount before choosing the method? Be certain before you vote. Taxpayers will pay attention this year. Time will tell.

Cecil C. Young

Mr. Young came forward and thanked the Council for the time to speak. Mr. Young said that he had been a Democrat for the last 50 years and had just switched to being an Independent in order to run for Council. He spoke about the last 11 1/2 years and said that he was hurting. Mr. Young mentioned that the Mayor was going to run for Governor and went on to give his opinion on this.

Mr. Clyde Nicholson came forward and said that he was present to voice his opinion about the parking meters. He said that he was sad to find out that Mayor Ganim signed off on the parking meters and that the Council was being tricked into bad situations.

He said that Atty. Anastasi was no longer able to speak out in meetings and it was time for him to go. He said that Atty. Anastasi had cost the City thousands of dollars. Mr. Nicholson said that Atty. Anastasi can't be touched because he is above the law.

Mayor Ganim showed up late to the meeting and Mr. Nicholson claimed Mayor Ganim signed the contract before the City Council had even voted on it.

Mr. Nicholson pointed out that the Mayor's job was 24/7 but Mayor Ganim was running around the State campaigning for the Governorship with a City vehicle and being chauffeured by a city driver, who is being paid by the City.

Mr. Nicholson said that the parking meters contract had a 120 days before it had to be signed. He added that he had just spoken with a restaurant owner who had to close because of the impact the meters had on his business.

Mr. Spain came forward and said that there were two items on the agenda he was concerned about and that everyone wants the City to prosper. The Connecticut Post reported that the new proposal was for a major development with the renovation of the two theaters, over 120 hotel rooms and a historic house, which would be all done by the same developer.

Mr. Spain wondered if the individual who claimed that the project was straight forward was present. Mr. Bill Coleman said that he was the one who had made the statement. Mr. Spain wondered why there were no experts, historians, and other project development strategists. He said that he would like to know who decided that the Poli theater would be divided up into family friendly spaces.

She pointed out that it was important to know how much a unit of water was and how much it costs. Because they don't, they are losing their homes. She said that it was wonderful what Mr. Young played because it shows how people need to know their government.

Ms. Mack spoke about a child who had been suspended from a charter school, the fact that there is no need for another train station and added that the State lotto money was unaccounted for. Now she is hearing that the MERS payments are going to be reduced. Shame on those who are representing the residents. Ms. Mack said that she likes Trump because he tells the truth the way that the people see.

Mr. Jorge Cruz came forward and said that he lives on Black Rock Avenue. He said that he would like to have the resolution that would prevent UI from cutting down the trees in the City. Council Member Vizzo-Paniccia said she will be voting against the item in Committee because the contracts are not thorough. She said that she had just gotten the paperwork earlier in the day.

Council Member Holloway said that he had just gotten the information and had some concerns about this. Mayor Ganim pointed out that the item was just the Memorandum of Understanding (MOU) and not the Land Disposition Agreement (LDA). The Council Members just received the LDA and have 30 days to review it. The MOU was distributed some time ago for the Council to review.

Council Member Vizzo-Paniccia said that this was not a good project because there was no guarantee that all the information was legitimate.

Council Member Lyons said that she was out of town when the contract was distributed. She said that she would not be voting for this until it is going to Contracts and she will do her due diligence during the Committee meeting.

Council Member Olson made a comment about President Trump and went on to say that initially that he Council can't be going into this blind folded. He said that he was confident it would work out well.

Council Member Taylor-Moye said that it would have to go back to contracts. Now it looks like they will be able to do the job and get the project off the ground. She said that she will be voting for the revised MOU.

The Mayor said that this was not the LDA and there would be a public hearing for the LDA.

** COUNCIL MEMBER CASTILLO MOVED TO AMEND BY SUBSTITUTION TO ENSURE THAT SPECIFIC LANGUAGE WITH REGARDS TO THE LDA LANGUAGE GO BACK TO THE CITY COUNCIL.

Mayor Ganim pointed out that the LDA had been separated out and would be voted on in a separate vote by the City Council. This vote is only on approving the MOU, not the LDA. This amendment by substitution is to clarify the item.

*67-16 Public Safety and Transportation Committee Report re: Resolution requesting that the City's Tree Warden require all Utility Companies working in the City to include in their Annual Vegetation Management Plan a language with clear signage regarding postings on any tree marked for pruning or removal.

Council Member Lyons said that while she was one of the chairs for that Committee, she had been out of town when this was on the agenda.

** COUNCIL MEMBER OLSON MOVED TO REFER THE ITEM BACK TO COMMITTEE. ** COUNCIL MEMBER HERRON SECONDED.

Council Member Olson said that this resolution was in violation of State law.

Council Member Banta said that he would like this item to be voted on at this meeting. He pointed out that no one is against having the utility companies trim back the trees to keep the electricity coming. However, they have been cutting down trees that were perfectly healthy without any notification. That is all anyone wants.

Mayor Ganim said that he thought everyone was basically on the same page. However, he pointed out that there may have been some procedural issues raised and that is why it should be referred back to Committee.

Council Member Vizzo-Paniccia said that there were a number of trees that were planted and no money was allocated to maintain them. The trees shouldn't be planted near sidewalks and overhead wires. Notices about the removals were sent out last year.

Council Member Feliciano asked who created this and if copies of it could be sent to everyone. Council Member Banta said that he had authored the item and would see that she received copies of the information.

Council Member Holloway said that all trees that are in the city's right of way are handled by the Parks Department. There should be postings before the trees are removed.

Council Member Lyons said that she was in favor of sending it back to Committee. Now it looks like they are planning a golf course.

Council Member Taylor-Moye said her concern was that this needed to move forward. UI is taking the trees down, but they are leaving the stumps where people can trip on them. UI should be posting the demolitions. She said that UI should come before the Council and present the information.

The Mayor suggested that it be sent back to committee.

Council Member Bukovsky said that she was one of the co-sponsors and would like to amend the ordinance and have the Tree Warden post on the trees. This should be an ordinance vs. a resolution.

Council Member McBride-Lee said that as chair of the Public Safety and felt there was nothing wrong with having the postings.

Council Member Martinez said that UI should be held accountable to post the removals. If the City has to get permits to remove a tree, so do the utilities.

Council Member Vizzo-Paniccia said that regarding the tree stumps that had been left by the city in the past, if they want UI to remove them, then the City should remove the stumps they have left in the past. A brief discussion followed.

Council Member Herron said that with the tree stump issue, the City cannot continue to do in kind services for these organizations. They are making the City look foolish. The regulations say that the trees need to be trimmed if it was 8 feet from the wires, but other trees not near the poles were being taken down.
