

- *This map uses the proportion of outpatient visits to healthcare providers for influenza-like illness to measure the ILI activity level within a state. It does not, however, measure the extent of geographic spread of flu within a state. Therefore, outbreaks occurring in a single city could cause the state to display high activity levels.
- *Data collected in ILINet may disproportionately represent certain populations within a state, and therefore may not accurately depict the full picture of influenza activity for the whole state.
- *Data displayed in this map are based on data collected in ILINet, whereas the State and Territorial flu activity map are based on reports from state and territorial epidemiologists. The data presented in this map is preliminary and may change as more data is received.
- *Differences in the data presented by CDC and state health departments likely represent differing levels of data completeness with data presented by the state likely being the more complete.

SUMMARY

There were 84 new laboratory confirmed cases of influenza reported in Bridgeport for the week ending 2/24/2024; this is a 12.5% decrease as compared to the previous week, bringing the total number of cases since 10/01/2023 to 1,402 for Bridgeport. Cases continue to impact the 45-65 year age group more heavily than any other (with 21.5% of the reported cases), with the 5-15 year age group as the second most impacted (with 19.1% of the reported cases). The incidence rate decreased from last week (64.7 per 100,000 to 56.7 per 100,000). By zip code, 06607 and 06608 experienced and increase in incidence rate while all other zip codes saw a decrease in incidence rate.

For the week ending February 17, 2024 there were approximately 1,094 new influenza cases in Connecticut, 64 hospitalizations, and 2 deaths. Fairfield County has decreased to low levels of influenza like illness (ILI) activity.

Connecticut was at moderate levels of ILI activity for the week ending February 17, 2024. Nationally, there were 7 states/regions at very high ILI activity levels, 20 states/regions at high levels, and 11 states/regions at moderate levels.

PRECAUTIONS TO TAKE

- Get vaccinated every flu season
- Cover your coughs and sneezes
- Wash your hands often
- Avoid touching your eyes, nose, and mouth
- Clean and disinfect surfaces that may be contaminated with the flu virus
- Avoid close contact with people who are sick and if you are sick limit contact with others
- If you have the flu, stay home for at least 24 hours after the fever is gone (except to get medical care or other necessities) without fever-reducing medication
- Take antiviral drugs if your doctor prescribes them
