President Nieves welcomed everyone to the public speaking session then asked everyone to be mindful of the three minute rule for those looking to speak to the council and for those in the audience to respect the speakers. She also welcomed the Youth Ambassadors who were in attendance.

Lisa Becker Resolution 20-23.

Jewish Federation of Greater Fairfield County 4200 Park Avenue Bridgeport, CT 06604

Ms. Becker greeted the council and shared that she only wants peace for everyone. She thanked the Miscellaneous matters for reconsidering resolution 20-23 as many cities are looking to Bridgeport for leadership on the issue. She believed this resolution didn't consider any Jewish community and it only created a bigger divide within the city.

Muhsen Youssef 125 Kossuth Street Bridgeport, CT 06608 Ceasefire Resolution.

Mr. Yourself was not in attendance to speak at the public speaking session.

Mohamed Hamada 665 Boston Avenue Bridgeport, CT 06604 Ceasefire Resolution

Mr. Hamada greeted the council and stated resolution 46-23 that was passed on January 2nd was an insult to the council as they are the voice of the city and this act shows how the council dismisses their constituents. He shared there has been a lot of lies and Zionist propaganda being shared during these meetings, even in the resolution. He stated President Nieves nor council member Burns would not allow any antisemitic behaviors in the chamber. Mr. Hamada asked council member Burns to reconsider his stance on the resolution and be an ally towards peace and ending the war.

Mohamed Ali 2370 North Avenue Bridgeport, CT 06604

History of Palestine.

Mr. Ali greeted the council and stated Muslims and Israelis have been living alongside each other for many years. They have both went through torture and deaths, and much more. Resolution 20-23 is a ceasefire to end the war and protect both communities.

Sarah Ibrahim 88 Harbor Avenue Bridgeport, CT 06605 Ceasefire Resolution.

Ms. Ibrahim stated she is a 15 year old proud Palestinian Bridgeport resident looking to shed light on people losing their basic human rights in the Middle East. With this occupation and genocide there are people eating grass due to no access of real food. A ceasefire is needed to protect, rebuild, and allow for a real conversation to be had.

Pastor Anthony Bennett Mount Aery Baptist Church 45 East Eaton Street Bridgeport, CT 06604 Ceasefire Resolution.

Mr. Bennett greeted the council and stated at previous meetings he has seen signs and heard people share ignorant and condescending opinions regarding the city making a stance on international affairs when Bridgeport is an international city. The council has a moral obligation to pass the ceasefire resolution to show to their constituents that they are being acknowledged. As an African American he stands for human rights and peace. He is ashamed to have heard of many financial contributions to the city that has only bought silence. He ended his statement by sharing that the resolutions did not create a divide but only revealed them.

Tarek Etman 120 Huntington Turnpike Bridgeport, CT 06610 Ceasefire Resolution.

Mr. Etman greeted the council and shared that the issues within the Middle East have been going on for decades. Many lives have been lost including innocent children during these war times. He believes these issues are forever lasting due to land and identity. For over 70 years Palestinians have been living under the occupation under the Israeli state and Gaza is treated like an open air prison with their ports and airports being destroyed since 2014.

Khaled Elleithy BICC 703 State Street Bridgeport, CT 06604 Ceasefire.

Mr. Elleithy greeted the council and shared that the members of the Bridgeport Islamic Community Center are proud of the city council in regards to passing the ceasefire resolution and having other cities in Connecticut look to them as trailblazers. On the other hand, he is ashamed that people on many platforms have not read the resolution and broadcast it is to destroy the Israeli government when in fact it is to create peace, stop killing lives, and protect humanity. He asked for the council to continue to advocate for justice and peace.

John Marshall Lee 30 Beacon Street Bridgeport, CT 06605 Finances & Governance.

Mr. Marshall Lee greeted the council and acknowledged the elections for Mayor have been finalized and commented the process is not righteous or just with reports of over millions of dollars being collected while under 10,000 votes were collected. Mr. Lee went on to say he appreciates the recent engagements at the public speaking sessions but the council isn't engaging or discussing anything being said. He suggested a better communicative speaking forum between the constituents and city council so everyone can understand and learn and be more innovative with proposals.

Aziz Seyal BICC 703 State Street Bridgeport, CT 06604

Ceasefire resolution.

Mr. Seyal greeted the council and saluted the council members who were staying firm on defending the resolution. He doesn't understand why anyone would not support the resolution as it is a call for peace and ceasefire. Someone has wrongfully spoken to the press as a scare tactic to stop Jewish investors from working or donating to Bridgeport businesses. As an investor of Bridgeport himself he sees the changes firsthand, even the real estate industry is changing.

Mohammed Shaham 866 Beechmont Avenue Bridgeport, CT 06606 Ceasefire resolution.

Mr. Shaham greeted the council and began to share that the community will not give up and keep advocating for the ceasefire until all the innocent lives are returned, human rights are returned, and the killings stop. He asked for a moment of silence for the American soldier who committed suicide to advocate for the ceasefire.
