Proposed Amendments to the Municipal Code of Ordinances, Chapter 3.16 – Property Taxes, amend Article II – Real Property Tax Relief for Senior Citizens, Section(s) 3.16.110 – Real Property Tax Relief and Maximum & 3.16.120 – Application for Real Property Tax Relief. **[39-23]**

1. John Marshall Lee, 30 Beacon Street Bridgeport, addressed the Committee and spoke about municipal government and the need to have more opportunity for community involvement, to understand impact on issues for compensation when the grand list is flat.
