still complaining about the mud. Mr. Saffan said that they would be meeting with engineers and the City to see if they can figure out a better solution.

Commissioner Hosier said that there were concerns about traffic control and asked if there was any ways it could be improved. Mr. Saffan said that he had met with Police Chief Porter, and they have worked out a way to improve the situation. The goal is to have people who have not been to Bridgeport before to come to the Festival and to Bridgeport.

Commissioner Wade asked how many food trucks they would have. Mr. Saffan said that he guessed it would be about 50 and they try to have as many local vendors as possible.

REPORTS

• Director's Report

Mr. Caulfield said that all of the projects were stalled due to the time of the year. He reviewed the details of the reports.

The discussion moved to the Ash Creek estuary. Commissioner Hosier asked whether there were signs warning people that the shellfish was contaminated. The Ash Creek Conservancy wants to discuss extending the fences with the Parks Commission next month.

Mr. Caulfield said that the fencing would start behind the Blue Star Garden and noted that they had gotten confirmation on some funding. He added that DEEP has already stated that the City had already met their obligations, but this would be a best effort to protect the area. The key is to get this approved so this fencing could be installed before the fishing season starts. Mr. Caulfield said that he would like to table the item at this time until he can assemble all of the information for the Commissioners.

Black Rock Little League has asked if one of the Ellsworth Park fields could be adjusted for T-ball. He said that they could decide to readjust the new Little League field or adjust the softball field.

Commissioner Labrador said that T-ball is usually played on an open field. He said that this had not been mentioned when they were getting ready to redo the newly renovated field down there. He said that he said that they would have to go down to look at the softball. Discussion followed.

Mr. Caulfield said that he was just mentioning this because the Commissioners would be presented with this soon.

Mr. Nastu said that the Bridgeport Public Schools Little League Basketball season had just concluded and it was a big success. The Night Rec programs is underway and will end on April 25th. There is an indoor track conditioning program that just started up again.

The planning for the Summer program is underway and registration is set for April 15th and they are also working on Park permits. The stickers are on order and should be delivered by the end of the month. They were ordered with the price listed on them.

Commissioner Labrador asked if they had started looking for life guards. Mr. Nastu said that Ms. Conine had already started reaching out to the life guards that had worked for the City before.
