#### CALL TO ORDER

Co-chair Vizzo-Paniccia called the meeting to order at 6:06 p.m. There was a quorum present at the time of roll call.

64-23 Refund Excess Payments – Phoenix Petro Corporation.

Ms. Jones explained the company is requesting to roll over the funds to the tax bill in July.

Co-chair Vizzo-Paniccia asked if this was okay with the department.

Ms. Jones replied yes, they can just roll it over for the next bill.

Co-chair Vizzo-Paniccia asked the city attorneys if they should table the item or approve it.

City Attorney Bohannon added it would be a refund of excessive asking to be allocated to the next bill. It would be best practice to receive something in writing per his request to then give him a receipt of the payment.

Co-chair Vizzo-Paniccia asked to submit the paperwork before the next city council meeting.

# \*\*COUNCIL MEMBER MCCARTHY MOTIONED TO APPROVE AS AMENDED ALLOCATING REFUND EXCESS FUNDS TO JULY TAX BILL. \*\*COUNCIL MEMBER ORTIZ SECONDED THE MOTION. \*\*THE MOTION PASSED UNANIMOUSLY.

91-23 Refund of Excess Payments – Webster School Realty LLC.

Ms. Jones explained the company is requesting their excess payments of \$21,346.34 to be refunded to them as they sent in their payment to the lockbox service but they also sent another payment to city hall.

Ms. Jones replied no, not to her understanding.

**85-23** Appointment of Thomas Masanotti (D) to the Parks Commission.

Mr. Masanotti shared he grew up in Bridgeport city as a resident of 66 years. He has spent much time at Seaside, Beardsley and at Fairchild Wheeler playing golf. He would like to learn about the back end on how the parks are managed, he would like to contribute to the parks as someone who is always here. He has concerns that he would like to bring up regarding the parks and has the time to contribute to the commission.

Council member Taylor-Moye shared she was on the commission before and the meetings are long and include park visits and working with others. .She asked how well he would work with other commissioners.

Mr. Masanotti replied he would work well with anyone interested in the city parks. He is looking to offer his observations to better the parks, and learn how to commission works; he has no intention to take over.

Council Member Pereira asked if he changed his political party affiliation in September from unaffiliated to democrat due to any request.

Mr. Masanotti replied that it was something he did on his own.

#### **\*\*COUNCIL MEMBER ENEIDA MARTINEZ JOINED THE MEETING AT 6:22 PM\*\***

Council Member Pereira asked Mr. Toledo why Mr. Cotto and Mr. Labrador are not on the commission anymore and the commission is required to have 8 members on the board.

Mr. Toledo replied he only manages the applications and their term expired.

Co-Chair Vizzo-Paniccia added that Council Member Pereira should contact the administration in regards to the nominations as internal affairs shouldn't be discussed at the moment.

**86-23** Appointment of John Hosier (U) to the Parks Commission.

Mr. Hosier shared he has been a Bridgeport resident most of his life. He is very honored to serve the city of Bridgeport and would appreciate being reappointed to the board as he has served 3.5 years so far. He has seen a lot of progress during his time and advocates for hiring more workers on the park grounds and a park director.

Co-Chair Vizzo-Paniccia added she has worked with Mr. Hosier on issues of the parks and he is very responsive. He sees his passion and dedication to the parks of the city.

Mr. Hosier added he believes the commission should work together with the council as with them they can accomplish more.

Council Member Taylor-Moye added she had the pleasure to work on the commission with Mr. Hosier and he was always willing to help and get people in the loop. His objective was just to make operations work right for the parks.

Mr. Hosier replied thank you.

Council Member Martinez added she cannot vote on the committee level but will be in favor of his reappointment once it goes to the council.

Mr. Hosier replied thank you.

Council Member Pereira asked if it is his intention to be chair of the commission.

Mr. Hosier replied it is up to the park commission as a whole, he isn't something he is actively seeking out.

#### 87-23 Appointment of Lillian Ortiz (D) to the Parks Commission.

Ms. Ortiz shared she is a lifelong resident of Bridgeport who has recently retired in February from the Norwalk Housing Department. She would like to use her passion and love of Bridgeport. She has reviewed the charter, minutes of the meetings, and learned about all 35 parks in the city. She would like to advocate the laws and regulations that have been set.

Council Member Pereira asked why she didn't apply to the fair rent or housing commission with her excellent experience and knowledge.

Ms. Ortiz replied she was tired of the industry and was looking to volunteer in another public sector.

Council Member Pereira added it is impressive for her to read minutes and the park section of the charter since you don't hear that too often.

Council Member Pereira added she highly recommended Ms. Clemons as she has experience as the superintendent of Bridgeport Public Schools.

Ms. Clemons replied thank you.

Ms. Turner shared she is a social worker and has experience with nonprofit development for 10 years. She moved to Bridgeport 4 years ago and decided to join the commission to learn more about where she lives and support the community.

Council Member Pereira asked what district she resided in.

Ms. Turner replied she is unsure of the district but lives in the north end.

Co-Chair Vizzo-Paniccia added she lives in the 134th district.

Council Member Martinez added she served with Ms. Bukovsky during her time on the council and she was very neutral on making motions. She would be in support of this when it reaches the floor.
