# CALL TO ORDER

Mr. Katz shared that the training program is in collaboration with The WorkPlace to train and certify 270 students. The city match will be covered by The WorkPlace and the Bridgeport Regional Business Council. It will be a four year grant totaling \$3.3 million dollars.

Mr. Schroeder added this will be exclusive to residents in Bridgeport and those in the re-entry population will be prioritized. They will have a pathway of employment after completing the training.

Council member McBride-Lee asked how they would promote the program.

Mr. Schroeder replied they would be working with the city channels, the mayor's re-entry program, and the city council.

Council President Nieves raised concerns regarding training to employment, she believes all this information should be tracked and suggest they get into the street to advertise for the program.

Mr. Schroeder added they will be providing transportation, childcare, and food for the trainees. He said they can build community engagement to connect with the residents in their local areas further than by calling them to informational meetings.

Council member Burns said there are many organizations in support of the program and businesses want to set up in the city but we need to help supply the workforce.

Council member Ortiz added he approved the item at the last meeting but has changed his mind due to the list of members they shared and with her personal experience with training, he couldn't find a job because the need wasn't in the city at the time.

Mr. Schroeder replied there is an urgency to work on climate change and being a greener city. The certificates are owned by the trainee and can find work anymore they please. The program will be creating a pathway to employment so after they graduate there will be jobs lined up for them.

Council member McBride-Lee suggested they should extend the start back just in case people fail to show up they can substitute their space.

Mr. Katz replied they can request budget revisions.

Council President Nieves asked if the residents need to native born or can people apply with work authorizations.

Mr. Katz replied that the goal is to include everyone.

125-23 Grant Submission: re Southwestern Connecticut Agency on Aging (SWCAA) - Title III Funding Older Americans Act Grant Program - Elderly Hispanic Outreach Program (#25270).

Mr. Katz shared this grant funding is to provide bilingual information to the elderly, pay the wages to the coordinator, and food, beverages, and marketing material. They are funded every year and provide assistance to the elderly on services available on a one on one and group basis.

Ms. Acevedo shared she is the Elderly Hispanic Outreach Coordinator and helps people over 60year-olds with application and appointments for social services.

Council President Nieves said the senior population is growing and asked why the grant was reduced.

Ms. Acevedo replied she goes to all of the senior centers in Bridgeport along with home visits.

Mr. Katz added SWCAA sent them a correspondence on how to better their application for next year.

Council President Nieves said they should record data to justify why they need the money especially as the biggest city in the state.

Ms. Helen shared the salary wage is for vendors; employees get paid hourly. The money will be used to provide physical activities to three locations as the East Side has their own funding.

Council member Burns asked what programs do they provide and will be coming in.

Ms. Helen replied they offer tai chi, chair exercises, ceramics, and painting. She added seniors can go to any location even throughout the day. They are also looking to add yoga to the list.

Council member Nieves asked what is the maximum someone can apply for.

Mr. Katz replied it is capped at \$50,000 dollars.

Council member Cruz asked if there is transportation available to the seniors.

Ms. Helen replied yes.
