The Civil Service Commission of the City of Bridgeport will conduct a competitive promotional examination for **Fire Apparatus Foreman**. The exact date, time and location of the examination has been communicated to all qualified candidates.

SALARY RANGE: \$107,672 - \$112,803 - \$117,944; appointments to be made at the minimum or entrance salary of \$107,672 per year. Advancements within the salary range may be made in accordance with the terms of the contract between the City of Bridgeport and Bridgeport Fire Fighters Local 834, AFL-CIO.

APPLICATIONS: No new applications are being accepted at this time.

DUTIES: Supervisory and skilled work of more than ordinary difficulty and responsibility, with direct responsibility for supervising the maintenance, repair and installation of fire hydrant and related equipment; related work as required; performed under technical direction.

REQUIREMENTS: This examination is open to members of the Bridgeport Fire Department who have occupied, with tenure, the position of Fire Equipment Mechanic for not less than three (3) years immediately preceding July 1, 2024, and who meet the following requirements: extensive knowledge and mastery of skills of hydrant planning, inspection, maintenance and repair; extensive knowledge of department rules, regulations and orders; through knowledge of hydraulics as they apply to firefighting requirements; mechanical ability; supervisory ability; ability to keep records and reports; ability to prepare specifications covering requirements for fire hydrants and related equipment; resourcefulness; industry; good judgment; good health and freedom from disabling physical defects.

SUBJECTS OF EXAMINATION: Oral examination and performance test on the knowledge, skills and abilities involved in performing the duties, relative weight, 7; seniority, relative weight, 1; training, experience and general qualifications, relative weight 2. Candidate will be required to attain at least 75% in each announced subject of examination. Candidate will be required to pass a qualifying service rating in order to be placed on the employment list.

SPECIAL ACCOMMODATION: The Civil Service Commission will provide reasonable accommodation for persons with a disability to take a test. To request special accommodation, please submit, in writing, a statement of what type of accommodation is being requested. You will be required to provide proof of any disability requiring accommodation. This request must be received by the Office of the Civil Service Commission at least 14 days prior to the examination date.

EXAMINATION REVIEW PROCEDURES: Each candidate will have an opportunity to review his or her examination during the one-month period after the date of announced results. The papers will be open to inspection during the hours of 9:00 A.M. to 1:00 P.M. Monday through Friday, excluding holidays. Every inspection period will be monitored by the staff of the Civil Service Office, and no candidate will be allowed to copy examination questions or to take any written material from the review room.
