Salary and Benefits: \$74,908.00 annually. This position includes a comprehensive benefits package. This summary provides a brief overview of the benefits available to regular full-time municipal employees; depending on the employee group some of these benefits may include retirement pension administered by CMERS (Connecticut Municipal Employees Retirement System), health insurance (medical, dental, vision, prescription), life, disability, paid leave, paid holidays, 457(a) deferred compensation plan (employee paid), and other voluntary employee-paid benefits. This is a unionized position.

This summary provides a brief overview of the benefits available to regular full-time municipal employees. Depending on the employee group, some of these benefits include health insurance (medical, dental, vision, prescription), life insurance, short- and long-term disability, paid leave (sick, vacation, and personal), paid holidays (13), and more.

The City of Bridgeport also offers several voluntary benefits programs via automatic payroll deduction: 457(b) Deferred Compensation Plan with Roth options, legal services, and complimentary discounted perks for city municipal employees. Tuition reimbursement is available to most City employees based upon the terms of the contract which covers the employee. Additionally, tuition discounts may be available at various universities and colleges that have partnered with the City of Bridgeport.

The city participates in the Connecticut Municipal Employees Retirement System (CMERS) (www.osc.ct.gov/rbsd/cmers/muniretire.htm), which requires both employer and employee contributions. Please be aware that your earnings from this position are not covered under Social Security; instead, you will make contributions towards your government pension plan. Municipal Profile

The City of Bridgeport is in Fairfield County at the mouth of the Pequonnock River on Long Island Sound. It is bordered by the towns of Trumbull to the north, Fairfield to the west, and Stratford to the east. The most populous city in Connecticut, it has an approximate population of 147,000, consisting of 50,367 households, with a population density of 9,226 residents per square mile. Nicknamed the “Park City” for its over 40 public parks, including the Olmsted-designed Seaside Park and Beardsley Park, Bridgeport is a vibrant community, and was recently cited as the 11th most diverse city in the country (with some 85 languages spoken here). *NBC Today* also labeled Bridgeport one of the [top 5 booming cities in the nation](#). The City is also home to numerous attractions, such as the [Barnum Museum](#), [Connecticut's Beardsley Zoo](#), the [Hartford Healthcare Amphitheater](#), the [Total Mortgage Arena](#), and the [Soundside Music Festival](#), all of which bring thousands of visitors to the city each year for a myriad of events. A center of learning, Bridgeport is home to Sacred Heart University’s Center for Healthcare Education, the University of Bridgeport, and Fairfield University’s Bellarmine Campus, as well as the campus of the Paier College of Art and the Housatonic Community College. The city also hosts two major medical centers which serve the region and are the city’s largest employers: Bridgeport Hospital, which is part of the Yale New Haven Health Care System, and Saint Vincent’s Medical Center, which is part of Hartford Healthcare. [Connecticut's Beardsley Zoo](#) is one of the most visited tourist attractions and the only zoo in the State. The [Sacred Heart University's Discovery Museum and Planetarium](#), located in the North End of the City, offers interactive science and space displays. Additionally, Bridgeport is home to [Vinny Brand's Stress Factory Comedy Club](#), [Downtown Cabaret Theatre](#), and many [fine dining](#) options.

Governing Structure

The City has a Mayor-City Council form of government. Bridgeport has an elected mayor who serves as the chief executive officer of the municipal government and serves a four-year term. The current mayor is Joseph P. Ganim, who is currently serving his eighth term as mayor. The City Council is the twenty-member legislative body whose two major responsibilities are enacting ordinances necessary to ensure the welfare and good order of the City and adopting the City’s [annual budget](#). Councilmembers are elected by the residents of the ten council districts to represent the concerns, needs, and issues of their constituents, and work to improve the City’s neighborhoods. All Councilmembers serve a two-year term in office.

GENERAL STATEMENT OF DUTIES:

This position will provide professional public health nursing care for the Bridgeport Health Department Communicable Disease Division. The role will entail various duties including interviewing patients in the STD/TB clinics for the prevention of communicable diseases; following up on reportable diseases; administering college vaccines; performing blood draws; conducting foodborne investigations for epidemiological follow-up and other clinic duties as required, including but not limited to; maintaining records of public health nursing services rendered; and other tasks assigned.

TYPICAL TASKS OR ASSIGNMENTS:

- Conducts home visits in connection with the care and prevention of communicable diseases.
- Applies principles of epidemiology in disease investigations, community assessments, and determining service needs of individuals, families, or communities.
- Ensure patient compliance with medically ordered therapies, attendance to scheduled medical appointments, and follow-up care in the community.
- Administers medications, including immunizations, following physician's instructions.
- Instructs families in the care of patient/client filing or searching of files; directs callers.
- Participates in community education and individual patient/client education in specialized programs, e.g., HIV, AIDS, Tuberculosis (TB), Sexually Transmitted Disease (STD), family planning, adolescent health, and related programs.
- Participates in the provision of public health and related medical services at neighborhood, mobile, and outreach clinics.

- Complete documentation and verbal reports as required by the Communicable Disease Division, and state-mandated surveillance reports, and obtain needed information for reporting when necessary.
- Work with local pharmacies to ensure the availability of medically ordered therapies to patients to maintain adherence to treatment.
- Identify opportunities for preventative treatment among case contacts, family members, and household members of patients receiving services through the Communicable Disease Division and Connecticut DPH TB Control program to link these individuals to care.

MINIMUM QUALIFICATION REQUIREMENTS:

As to education, training, and experience:

- Nursing degree from a nationally accredited college or university.
- Completion of a one-year course of study in public health nursing at an accredited school.
- Any equivalent combination of education and experience.

As to special knowledge, ability, and skill:

- Good knowledge of the principles and practices of general professional nursing care.
- Good knowledge of the principles and practices of public health.
- Ability to establish and maintain harmonious and effective working relationships with patients, other health workers, and the public.
- Ability to utilize computers, including a variety of software and statistics programs per Connecticut State Department of Health program protocols.
- Ability to provide direction and guidance to others independently and in collaboration with clinicians and coworkers.
- Ability to maintain clear documentation and reports, with the understanding these may be audited by the nursing supervisor, treating physicians, the Bridgeport Health Department Medical Director, and State of Connecticut DPH program officials.
- Working knowledge of safety and infection control principles, practices, and methods.

LICENSES AND CERTIFICATIONS

- Valid Connecticut Driver's License — This job requires daily driving.
- Possession of Connecticut certification as a registered nurse.

PHYSICAL DEMANDS AND WORK ENVIRONMENT

- The physical demands and work environment characteristics described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. - While performing the duties of this job, the employee is frequently required to walk, sit, talk, or hear. 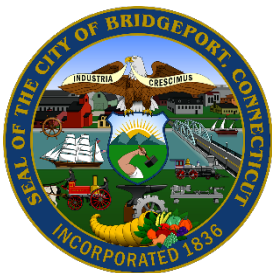
