The Civil Service Commission of the City of Bridgeport will hold a promotional examination for **Fire Equipment Mechanic**. The exam will be held on a future date and at a location to be determined. All qualified candidates will be notified of the exact date, time, and place.

Salary Range: \$87,808 - \$90,741; appointments to be made at the entrance salary of \$87,808 per year. Advancements within the salary range may be made in accordance with the terms of the contract between the City of Bridgeport and fire employees Local 834, AFL-CIO, IAFF.

Applications: Each candidate must complete an application form supplied by the Commission and file it no later than close of business on **Monday**, **December 2**, **2024**. Each candidate must submit a refundable security deposit of \$150 in the form of a payroll deduction authorization form during application. This security deposit will not be deducted for any applicant who appears for all parts of the examination at the proper date and time*.

Duties: Skilled technical and mechanical work of more than ordinary difficulty and responsibility in the maintenance and mechanical repair of all types of fire apparatus and equipment; related work as required; work performed under technical direction.

Requirements: This examination is open to fire department members who will have been employed by the City of the Bridgeport's Fire Department as a fire fighter (or higher rank) for not less than three (3) years prior to November 18, 2024 and who meet the following requirements: extensive knowledge of and mastery of the skills of a mechanic in work on engines, hydraulic pumps and devices and other specialized mechanical equipment of the Fire Department; extensive knowledge of the theory and principles of operation of internal combustion engines, mechanical drive devices and hydraulic pumps and lifting devices; good knowledge of hydrant and pressures; working knowledge of modern methods of firefighting; ability to make repairs and adjustments and to check and recognized defects in motor vehicles and pumping apparatus; mechanical ability; physical strength; industry; resourcefulness; good judgment.

^{*} In order to ensure that candidates who apply will present themselves for the promotional competitive examination, the Civil Service Commission requires that all applicants provide the Office of the Civil Service Commission with a security deposit to hold a place for the candidate at the examination. This deposit will not be charged to any candidate who appears for each portion of the examination on the proper date(s) and time(s).
